#### **NEWS FROM THE CHAIR, Trevor Weatherhead AM**

1. Work continues on the harmonisation of the movement of live bees within Australia. This has been on the AHBIC agenda for many years now and we are finally getting somewhere. There is a working group formed consisting of the AHBIC Biosecurity Sub-committee and Departmental representatives from the various States and Territories. The first business is to try to see if the notifiable list can be harmonised as much as is possible. We are still working on a five (5) zone system.

The ultimate aim is to have beekeepers, who can prove they are conforming to the Biosecurity Code of Practice, able to provide

certification for heath certificates if they are required by a certain State. This will free up time for Departmental staff.

- 2. With the trend nowadays to have virtual meetings as face to face meetings are not possible, there was one occasion where I participated in one that was especially designed as a virtual meeting. It was the Australian Virtual Hobby Beekeepers Conference held in June. I was able to report on behalf of AHBIC. Great to be able to reach out to beekeepers from all over Australia.
- 3. Leilani Leyland chose not to stand again for the Executive at our AGM. My thanks to Leilani for her contribution to the Executive over the past four (4) years and also as Chair of the Education Subcommittee. Whilst Leilani has relinquished her role as Chair she is still on the Sub-committee representing BICWA.

Welcome to Danny le Feuvre who was elected as the newest member of the Executive.

Thanks also to Stephen Fewster who was elected as the Deputy Chair and Therese Kershaw who is the other member elected to the Executive.

4. The big migration is on with hives going into almond pollination. I have been told that up to 277,000 hives will be required. The Working Group consisting of State Association representatives, State Department representatives, AHBIC, almond industry and bee brokers has been meeting regularly to make sure that bees can move in and out without beekeepers having to quarantine. My thanks to those on the working group for their hard work.



#### **GOVERNMENT NOTIFICATIONS**

• The Department of Agriculture, Water and the Environment (the department) advises of the latest notification to the World Trade Organisation (WTO) from Indonesia regarding their expanded requirements for Halal certification of various products. It is understood that this will impact industries who seek to export products to Indonesia so the department is seeking industry feedback regarding this notification. Under the proposed requirements, many products not traditionally viewed as requiring halal certification will now require a Halal certificate to be issued by a Halal Certifying Body, who's duty is to audit and ensure your establishment is complying with appropriate procedural measures to ensure the integrity of the Halal system.

As part of this notification, the department has the opportunity to provide feedback to the competent authority in Indonesia regarding their proposed regulations and hope to incorporate industry feedback within this commentary. 
