NEWS FROM THE CHAIR, Trevor Weatherhead AM

1. I was recently part of a meeting with the Department of Foreign Affairs and Trade (DFAT) where they were reporting on the latest developments on the negotiations with the European Union (EU) on a Free Trade Agreement (FTA).

Currently there is a 17.3% tariff on honey going into the EU. In our submission to DFAT AHBIC has asked that this tariff be removed. Negotiations are still ongoing and I am hopeful that we will eventually have the tariff removed so we are not disadvantaged compared to some of the other countries that export honey to the EU.

There are some products that could be affected by geographical indicators (GI) but from what I have been told there are none that will affect us.

2. Over the years there has been talk of having a pollination levy put in place to allow for greater work in research and also the biosecurity field. Advice during that time was that it was most likely possible. Recently AHBIC asked the Department of Agriculture, Water and the Environment (DAWE) to put this advice in writing so we could move forward.

Unfortunately, the answer came back that a pollination levy was not possible as it was service and services could not be levied under the Australian Constitution. This seems strange when there is currently a levy on stallions servicing mares. AHBIC was advised that there will be a review of the levy system soon and the question of the pollination levy will again be raised.

3. AHBIC has been asked to be part of a survey by Apimondia about next year's meeting in Russia. I contacted several people who were at Apimondia in Canada last year for their opinion as I reasoned that they would be most likely to attend if possible. The reply I will give is that we are in favour of postponing till 2022 and hopefully the international travel and the Covid-19 problem will have been resolved by then.

4. Talking with beekeepers around Australia it seems that conditions vary greatly. In Queensland conditions are very dry and no one really knows where they will go after pollination of macadamias and avocados finishes. In Tasmania they are very happy with the way things are progressing but as they say until the honey is in the drum we will wait with anticipation. Victoria shows some promise along with South Australia and the west but in New South Wales it is a tale of two parts. The south shows some promise whilst the northern part is still dry in parts.

APIMONDIA UPDATE

Jodie Goldsworthy Oceania President

World Bee Day had to be converted to a small virtual event in May as a result of travel restrictions and lock downs. Despite this the day still received due focus and attention within FAO and the United Nations which is testimony to the good work of the Secretariat in Rome.

With this long relationship with FAO Apimondia is in its final stages of signing a MOU with FAO to allow the two organisations to work more closely together on initiatives and programs that raise the profile of beekeeping globally. The work on the relationship building and development of this MOU with FAO has been a work in progress and a focus for Apimondia over the last 3-4 years.

Apimondia initiated with FAO the develop a joint publication on how beekeeping contributes to the **Sustainable Development Goals (SDG's) of the United Nations**. To this end the Executive Committee of Apimondia have for the last 6 months worked to put together a publication 'Beekeeping contributes to achieve the Sustainable Development Goals'. This is the first of its kind to formally recognise at this level the link between beekeeping and sustainable development and will build on the importance of beekeeping as a keystone industry in terms of food security. The recognition of beekeeping as being able to contribute to all of the 17 SDG's is unique and the publication lists examples from all the Scientific and Regional Commissions on how this currently takes place. It should help to guide FAO and global policy makers on the strategic importance of sympathetic apiculture policies and programs into the future. Please see the link to the publication [here](#)

Looking towards more regular communications - One of the reasons for my Apimondia Executive Committee colleagues asking me to consider being renominated for the role of Oceania President was for my focus on helping Apimondia to build on its strengths, and to help explore better communicate with its members using a strategic approach. Through the new Presidency of Dr Jeff Pettis Apimondia is now entering into the new era of more regular communications and this is beginning at the Executive Committee level. Up until this year the Apimondia Executive met only once per year in non congress years. In Congress years the Executive met twice per year, once in May and once at the Congress. These meetings were face to face and much of the focus was on the congress organisation. Other communications through the year were via email. In my first four year term it took some time to learn the internal workings of Apimondia and follow what was happening. What was clear was that the correspondence to the Rome office from around the globe was massive and the potential to build on Apimondia also huge.

Covid 19 meant that the scheduled annual May meeting which was to be held in Rome took place over a weekend of extended Zoom sessions instead. For our part of the world with global time zones needing to accommodate every continent this meant some very late nights / very early mornings. I am so pleased that this technology has offered the opportunity of more regular meetings and the ability to begin working on a more coordinated Apimondia work plan which is currently under development.

Apimondia is planning to use technology to connect with members and beekeepers from around the world in some planned Apimondia Zoom sessions to be available globally. Watch this space and if you have any ideas or would like to hear more about a particular topic then please let me know and I can feed this back to the Apimondia Executive.

Efa - Russia Congress 2021 - The work is continuing in organising the Ufa Congress in Russia for 2021 albeit under the cloud of Covid. With the realities of Covid and a vaccine still uncertain the Executive Committee and the Ufa Organising committee are keen to hear the views of the member organisations in relation to next year's congress. Decisions will need to be made later this year on whether to hold the congress as planned or whether it should be postponed or made a virtual event. All member organisations will shortly receive a survey from the Rome Secretariat which asks for their thoughts on this matter. This will help inform the Executive and Ufa organising committee on member views before taking any next steps in these very uncertain times.

Bee Health Commission - The Apimondia Bee Health Commission received a new President in Montreal with Dr Jeff Pettis moving to President Apimondia. Dr Fani Hatjina from Greece is the new Bee Health Commission President. Fani called for nominations to a Bee Health Working Group from each of the Regional Presidents. Congratulations to Dr John Roberts from CSIRO who is the appointed Oceania member of the Apimondia Bee Health Commission. John's work on Bee Viruses was referenced and discussed during some of the sessions in Montreal and I am confident that John will make excellent contributions to this network. I am hopeful that other Scientific Presidents will take a similar approach to connecting global scientists to their commission which will allow greater connection opportunities for Scientists from every region globally.

Thank you ApiNZ I would like to formally thank the Board of ApiNZ who renominated me to stand for a second term as Oceania President for Apimondia following notifications to all members by Apimondia. Maureen Maxwell from New Zealand continues on as Vice President of Oceania Region and is always a terrific support as we approach these roles as a team.

Hello Fiji & aim to find other Oceania beekeepers to connect to Apimondia - I have also been pleased to connect with John Caldiera from the Fiji Beekeepers Association and to meet John in person in Montreal. It was great to be able to introduce John to the Apimondia network and to have John helping me with information from Fiji to pass back to Apimondia.

I am looking forward to working to try to better connect with other beekeepers from the Oceania region and would welcome anyone reaching out to me with contacts that they may have for beekeepers in other Oceania countries. With the FAO connection I feel that there may be opportunities to help support and better connect some emerging beekeeping countries from our region but during this time it would be helpful if anyone has any contacts to please pass them on so that I can reach out to them.

Now more than ever we need global solutions to local problems for bees and beekeepers and to this end the Apimondia network is well placed.
