THE LATEST ON ADULTERATED HONEY

In the last week of November, there was a meeting held in Melbourne including industry, Government, analytical companies and scientists. It was looking at the testing of honey and is there a reliable, enforceable test and, if not, how could one be developed.

In the recommendations a metadata analysis of all the chemical and pollen analyses undertaken on Australian honey also looking at any possible anomalies is to be investigated. Looking at the NMR testing and alternative methodologies is also to be examined. Also looking at producing an internationally recognised compendium of Australian honey is to be explored.

AHBIC and Government will be consulting on the various recommendations with a view to progressing them.

MINISTERIAL VISIT

On 3 November, 2018 a meeting was held at the beekeeping premises of David, Rosie and Jacob Stevens just outside Warwick with Minister Littleproud. Also attending were Peter Barnes, AHBIC Executive member, Ben McKee, Chair of the AHBIC Subcommittee on Food Safety and Prevention of Residues and Trevor Weatherhead. Thanks to David, Rosie and Jacob for making their premises available.

The Stevens showed us over their beekeeping enterprise. We then gave the Minister an outline of our industry and discussed with him about various beekeeping issues. Some of the issues raised were China exports, beeswax importation, honey testing and Regional Forest Agreements (RFA's).

Re the RFAs, the Minister told us to contact his advisor on this. We did and a meeting was held on 27 November in Canberra which is the subject of a separate item in this newsletter.

Overall we spent around an hour with the Minister and he was very receptive to our representations.

PARLIAMENTARY MEETING ON RFAs

On 27 November, 2018 a meeting, to discuss the history and current status of Regional Forest Agreements (RFAs) in Australia, was held with one of Minister Littleproud's advisors at Parliament House in Canberra. This was as a result of meeting with Minister Littleproud earlier in the month. Present were Ian Cane, Chair of the AHBIC Resources Subcommittee, Neil Bingley, President of the New South Wales Apiarists Association, Sarah Paradice, the incoming AHBIC CEO and Trevor Weatherhead.

Ian Cane had prepared a short paper on the current situation of the RFAs in Australia for the advisor.

We outlined the history of the RFAs in Australia and how they did not do the beekeepers any favours. In fact, in some cases, they are detrimental to beekeepers.

We discussed the current situation in the bush and, in particular, the current review of the RFAs being conducted in several States. The level of consultation in some of these reviews is not satisfactory. The advisor asked for some more information, which will be supplied. I feel it was a productive meeting and the advisor had a good understanding of our problems and will look to have input into the current and upcoming reviews.

HAVE YOU FILLED OUT THE SURVEY?

Back on 6 November, 2018 I sent out a separate screed re the survey that is being carried out on how healthy Australian bees are and what pests and diseases might be causing problems for beekeepers. This will give us some up to date data.

If you have not completed it go to http://bit.ly/BeeHealthSurvey and fill it out. It will only take 10-12 minutes.

The survey was originally to close on 14 December, 2018 but that has been extended to 31 December, 2018.

ALMOND INDUSTRY

According to the 2017-18 annual report from Almonds Australia they say, in regard to pollination, "It is estimated that the demand will grow from around 190,000 hives to 300,000 hives during the next decade. Given the estimated total number of commercial hives in Australia stands at 380,000, the need to build the number of hives available to service our pollination needs is obvious."

I believe they are underestimating the number of commercial hives but it is still an over 50% increase in the number of hives needed. I have been told by beekeepers in Queensland that when the price is right they will be available to supply hives for pollination.

The report also stated that production for the period was down due to "poor pollination conditions, widespread severe frosts and pest damage".

The total area under almonds stood at almost 40,000 hectares. New plantings will likely increase the area to 50,000 hectares in the next few years.

EXTENSION OF THE KIA FOR ASIAN BEES

Not surprisingly the Known Infested Area (KIA) of the Asian bee in north Queensland is slowly expanding. The most recent report was in the Mt. Carbine area. The southern spread is almost to Tully.

Examination of any Asian bees, so far, still shows that there are no *Varroa jacobsoni* on them in this KIA.

VEGAN HONEY

Still no word from the New South Wales Food Council on what action, if any, they will taken.

In the meantime I am still receiving reports of this product still being sold in stores.

SMALL HIVE BEETLE EXTERNAL TRAPS

IT WAS NOT THE LARGE AFRICAN HIVE BEETLE

Beekeepers may have heard a report of a large beetle being found in hives in the Biggenden, Queensland, area.

The Queensland Department for Agriculture and Fisheries collected samples and they were not the large African hive beetle but a native scarab beetle of the genus Bisallardiana. Further work is being carried out to determine the species. So no problems in this case.

BBO'S CAN HELP WITH ADVERSE REPORTING

I have written in several occasions about beekeepers filling out adverse reports and submitting to the Australian Pesticides and Veterinary Medicines Authority (APVMA) if they have an adverse experience in relation to chemicals.

In a recent newsletter AHBIC has made the offer to help you in this regard.

Recently APVMA held a teleconference with the Bee Biosecurity Officers (BBOs) and gave them a briefing on the adverse reporting method. So if you have experienced problems with chemicals affecting your bees you can now enlist the help of the BBOs in helping fill out the form.

HONEY BEE AND POLLINATION PROGRAM

AgriFutures Australia will not be running an open call for the Honey Bee & Pollination program in 2018, due to existing RD&E budget commitments and levy income uncertainty associated with the drought.
