THE LATEST ON ADULTERATED HONEY

As I understand it the original publicity using the NMR test is now with ACCC. Enquiries have determined that the NMR test is not recognised by Australian authorities or European authorities as an official test. Instances of contradictory results have been uncovered. So in its current form the NMR test seems to be deficient.

Re the second wave of publicity re the supposed failure of 18% of Australian honey, the Food Safety and Prevention of Residues Subcommittee had a skype hook up with one of the authors of the paper. Nothing was really achieved from that conversation except a lot more questions on the testing method and disappointment that the interpretation of the results of the study were sensationalised to the detriment of the honey industry.

Unfortunately the authors are refusing to reveal the source of their samples so it is not possible to carry out an investigation to see why it is claimed these samples failed. It is claimed that some were boutique honeys but we do not know the source. This is not satisfactory as it casts a cloud over all suppliers even though they may not have been tested or even if their samples passed. We have had reports of several suppliers being adversely affected by loss of sales through no fault of their own.

I note on the Capilano website that they have received information from one of the authors to say that the Capilano samples passed. So unless the authors are prepared to list the failures, the stigma is there on all other honey. Surely the suppliers of those honeys that are claimed to have failed need to know so they can instigate a check to see if there is some failure in their operation or if the testing method is at fault.

AHBIC's media advice has been to not argue the validity of the study through the media as this has the danger of confusing the consumer and potentially damaging the reputation of Australian Honey further. Hence AHBIC continues to work through the issues raised and gather information that can lead to a positive outcome for our industry.

There is to be a meeting held in Melbourne in late November looking at the methods being used for honey testing. This meeting will have in attendance industry, through AHBIC, regulators and scientists who will discuss ways forward from the issues that have been raised. This is to see if we can have an enforceable test that the packer and the public can have confidence in. Further details will be reported on in the next newsletter

EXERCISE BORDER BRIDGE

When AHBIC received information that Exercise Border Bridge was to be held, see <u>https://www.dpi.nsw.gov.au/biosecurity/borderbridge</u> a note was sent to the organisers re what would happen if there were bee hives on a property that was the subject of a quarantine standstill order.

In the foot and mouth outbreak in the United Kingdom many years ago many beekeepers lost hives because they were quarantined on infected properties and they were not allowed access to the hives for many weeks.

The answer that came back from the organisers of Exercise Border Bridge was:-

"The Australian Honey Bee Industry Council raised questions prior to Exercise Border Bridge in regards to the unintended consequences for the Bee Industry by way of quarantines imposed for Restricted Areas (RA) and Control Areas (CA). Whilst bees were not affected by the animal or plant disease in the Exercise, if a beekeeper had beehives in the RA or CA, there could be damaging consequences to the individual/industry if they could not access their hives.

Based on this enquiry we included an input into the Exercise to identify whether an RA or CA restriction would impact the movement of bee hives. It was determined during the exercise in NSW :

- Bee hives were not subjected to any special restrictions.
- A permit was required to move the hives from an IP, but this is the same as any movements from IPs.
- The conditions for movement were more related to biosecurity implications of the truck

Hives located within the restricted area would not be subjected to any specific movement conditions."

So this is good news and makes liaising with these Exercises worthwhile in identifying unintended consequences that can be sorted out now and not in the heat of an outbreak.

HAVE YOU DONE A BOLT COURSE

As part of the Biosecurity Code of Practice beekeepers with 50 or more hives must demonstrate a minimum level of knowledge of pest and disease identification and management. This can be an approved pest and disease management course such as the competency in the Certificate III in Beekeeping or the Biosecurity for Beekeepers course provided by Plant Health Australia (PHA) through the Biosecurity Online Training (BOLT).

The BOLT course is free for all beekeepers who own 50 or more hives and is free by way of a token (a 6 digit code). This token is available from your Bee Biosecurity Officer (BBO) or in the case of Queensland from the Department of Agriculture and Fisheries. For those with less than 50 hives it is available for \$20 and for overseas beekeepers it costs \$40.


For the BOLT course there have been 977 course enrolments since its inception. Of these 768 have completed the course.


Similar numbers of commercial and hobby beekeepers have enrolled in the course and there is a completion rate of approximately 80%. Initially there was a stronger uptake from the hobby beekeepers, but since the BBOs have been working with the commercial beekeepers and providing the tokens to access the course, the numbers have levelled out.

Victoria and New South Wales show the largest enrolment number, these states also have the largest numbers of beekeepers, but there is a steady uptake of the course nationally.

So if you have 50 or more hives and do not have a qualification of the Pest and Disease Competency under the Certificate III in Beekeeping then the BOLT course is for you.

PACIFIC LABOUR SCHEME

Below is some information received on the Pacific Labour Scheme.

I am writing to provide you with information about the Pacific Labour Scheme, a new Federal Government initiative which aims to assist businesses in rural and regional Australia meet their unmet demand for workers, by providing access to workers from Pacific island countries.

The Pacific Labour Scheme began on 1 July 2018. There are currently around 10 employers approved to use the Scheme and workers are already in Australia. The Scheme:

- is open to all industries, with a focus on: accommodation and food services; health care and social assistance; and **non-seasonal** agriculture, forestry and fishing industries;
- is employer-sponsored and requires labour market testing to ensure Australians have priority for local jobs;
- is designed for businesses in rural and regional Australia that are unable to find workers:
- allows citizens from Kiribati, Nauru, Tuvalu, Samoa, Solomon Islands, and Vanuatu (Pacific workers) to work in Australia for between one and three years;
- allows Pacific workers to fill low and semi-skilled jobs;
- includes an initial annual cap of up to 2,000 workers in 2018-19;
- is supported by the Pacific Labour Facility which provides assistance to workers and employers; and
- contains protections to safeguard against worker exploitation.
